The Global Talent Visa is one of the most streamlined permanent resident visas and is based on a sustained international record of outstanding and exceptional achievements in key target sectors.

This visa is suitable for start-up entrepreneurs, technological leaders in innovation driven/technology focused target sectors, including Agtech/Agri-food, Circular economy, Defence/advanced manufacturing and space, Digitech, Education, Energy, Financial service/fintech, Health industries, Infrastructure/tourism and Resources.

The Global Talent Employer Sponsored (GTES) program allows employers to sponsor overseas workers for highly skilled niche positions that cannot be filled by Australian workers or through other standard visa subclass 482 programmes.



Global Talent Visa / Global Business and Talent Attraction

Australia is keen to attract high value businesses and exceptionally talented individuals to bring their talents to Australia.

- A quota of 15,000 for year ending 30 June 2022 (including family members)
- Streamlined no requirement for skills assessment
- Age limit up to 55 (exceptional candidate can be over 55)
- One stop permanent residency
- Not points tested, No occupation lists
- · Can reside anywhere in Australia (regardless of state/territory) on grant
- International record of achievements (professional context or academia/research)
- High earnings (circa AUD162,000 p.a..)
- Be nominated by a suitably qualified Australian citizen or permanent resident
- Be able to self establish in Australia in the target sector and be an asset to Australia
